# PROTECT THE RIGHT TO VOTE

The Supreme Court decision in <u>Shelby County v. Holder</u> has suspended review of voting changes under Section 5 of the VRA.

# WE NEED YOUR HELP TO **DETECT** AND **BLOCK** DISCRIMINATORY VOTING CHANGES THAT UNDERMINE THE RIGHT TO VOTE!

#### **Look Out For These Potentially Discriminatory Changes:**

- Creating at-large voting districts
- Redrawing single member districts
- Changing municipal boundaries
- Changing the composition or structure of governmental bodies (e.g., a three-seat county commission becoming a five-seat county commission)
- Reducing opportunities to vote (e.g., reducing availability of early and/or absentee voting, reduction in numbers of polling places, reductions in numbers or poll workers and/or voting machines)
- New rules for registering and casting a ballot
- New rules for candidate qualification (e.g., new registration fee, new residency requirement, etc.)
- Implementing other special voting rules for at-large elections (e.g., run-off elections, residency districts, and numbered positions)

#### Red Flags:

- Changes that seem to be targeted in ways that disadvantage minority voters (e.g., adoption of inconvenient or hostile polling sites)
- Changes that are adopted last minute and/or without public comment
- Distribution of confusing or misleading information related to voting changes (e.g., explanation for the change doesn't make sense)

#### Other Issues To Report:

- Existing voting practices (rather than recent changes) that appear to be improper or questionable (e.g., maintaining atlarge voting districts)
- ➤ Irregularities in the processing of voter registration applications (e.g., not processing forms until right before the election, not calling voters to confirm missing information)
- Denying voters the assistor of their choice
- Deceptive practices, including: giving false information about voting (wrong date, false requirements, erroneous precinct information, etc.), and giving wrong directions to new polling sites
- Lack of language assistance from election officials
- ➤ Ballots that are not translated or poorly translated

#### Other Issues to Report Cont'd:

- Targeting minority candidates for harassment or unfair treatment
- Intimidating flyers, posters or other literature threatening voters
- ➤ Intimidating behavior by poll workers or others (e.g., uniformed personnel, guns, taking down license plates of voters)
- ➤ Harassing voters needing language assistance

# TAKE ACTION!

### STEP 1

Be involved and aware of voting practices in your local community! Attend your local county/city election board meetings, look out for changes reported in your local newspaper, become a poll worker, and be aware of red flags that could indicate potential discrimination.
